IX. Executive Director's Staff Report

<u>Park and Trail Grant Program FY15</u> - Executive Director Buehlhorn explained that the FY15 grant round application information was published in various newspapers.

<u>Department of Commerce and Economic Opportunity</u> - Executive Director Buehlhorn is currently working with the Department of Commerce and Economic Opportunity for the highway signage, and has a meeting in late July early August with the Department.

<u>Mounds – America's First City</u> - Executive Director Buehlhorn explained that Heartlands Conservancy is in the process of getting the Cahokia Mounds to be recognized at a national site.

<u>Corps meeting on wetlands delineation</u> - Executive Director Buehlhorn has met with the Corps and Bill Baudendistel on the Troy Scott site. They have walked the site making suggestions to avoid IPA issues. Approved use of the ground and ratios still need to be determined.

<u>IPARKS</u> - Executive Director Buehlhorn explained that we have received the new IPARKS renewal and there was an increase of \$809.00.

<u>Malcolm W. Martin Memorial Park</u> - Executive Director Buehlhorn mentioned that there seems to be increased visitor traffic, in the form of events, weddings and family reunions being held at the park this summer.

<u>Events / July 4th Activities</u> - Executive Director Buehlhorn stated that this year's event was small with approximately 324 visitors on the 4th. It was a great turn out and people enjoyed the event activities.

<u>Alton</u> - Executive Director Buehlhorn explained that Senator Haine has asked the district to assist the City of Alton in formatting a successful OSLAD grant. The Executive Director indicated that staff would review the application and make recommendations as they would with anyone else, but there is no promise of success in funds from IDNR. In addition, there was no guarantee MEPRD would fund the project unless it met all funding guidelines.
