## VII. Executive Director's/Staff Report

## Funding

For the second month in a row, sales tax amount was received and the amount had a slight decrease of about \$3,340 over the same period last year. The total amount to date is approximately 3.1 % over last year, or an increase to date of \$77,500.

#### Grants

We are in the application process for a \$30,000 grant from St. Clair County for energy efficient lighting at MMMP. The Executive Director has met several times with Springfield officials about a \$2.6 million grant for the bridge over TRRA at Bunge.

# Projects

Staff is working on the GIS map of expenditures with both affiliates. We have some information completed, some is slower to arrive. Should be completed by summers end for review.

## SCCTD

Staff has sent the invoice for the second installment for the Scott Troy Bike Trail to SCCTD in the amount of \$500,000. We expect payment in early July.

#### **MMMP**

There were some additional repairs required at the geyser. Hydrodramatics has installed a new control panel. The 20 year old panel was causing the pumps to shut off randomly during operations.

Luby has cleaned the outside generators from cottonwood clogs that were causing the generators to overheat and shut down.

As previously sent, the movie "The Layover" filmed at the park for the balloon scene with William H. Macy, Kate Upton and Alexandra Daddario. The movie should premiere early in 2016.

We have completed the information requested by Mr. Hier and prepared and mailed packets for our \$500,000 operational request from the Gateway Center. There will be a meeting in July to review the information.

## Meetings

The Executive Director met in Springfield with IDNR regarding the potential elimination of OSLAD and PARC grants and the status of our Troy/Scott grant for \$576,600 for acquisition. It is apparent our grant will remain intact, however at this time OSLAD and PARC grants are suspended for 2016.

Staff attended the re-dedication of the Ronald J. Foster Trail in Glen Carbon hosted by Madison County Transit.

Staff met with TWM representative Sheila Kimlinger regarding estimated costs on the TRRA bridge structure for the Front Street trail.

## FY16 Budget

The staff and Board reviewed the FY16 draft budgets for MEPRD and MMMP. There were minor changes in funding lines due to previous updates in FY 15 expenditures. In addition the Capital Budget was outlined which includes all current and proposed projects through 2020.

Planner Bryan Werner outlined the suggested changes to the Sponsorship and Matching Park and Trail Grant Programs. All Board suggestions were incorporated within the grants.
