Executive Director Bryan Werner presented the following:

• Grant Coordinator Position

 Advertised for the Grant Coordinator Position for two weeks in the Edwardsville Intelligencer and Belleville News Democrat. Received 25 resumes. Interviewed three candidates. Recommending one of the three in executive session.

• MEPRD Grant Programs

 We have received many inquiries about the new grant program. Additionally, the new funding scenario calculator seems to be working. Status reports will be sent out soon for the 37 projects currently on the books.

• Generator Rebuilds

- Oummins finished rebuilding the first of the three Gateway Geyser generators. They are about half way through the second generator. Currently only a single pump is operational because Hydro Dramatics just informed us that a control valve is needed for the pump operated by the newly rebuilt generator. We have yet to receive a quote for that work.
- Also, we just received our first of three invoices from Cummins for \$94K, which will be paid by MEPRD, after which we'll be reimbursed by Gateway Center of Metropolitan St. Louis.

• Front Street Project

o IL American continues the installation of a new water main along Front Street, after which the road and trail construction can resume. North of River Park Drive is expected to be finished this fall, followed by the south portion being finished next spring. Detours exist, forcing traffic via Trendley Ave.

- Troy O'Fallon Trail
 - Brewster finished most of the skidding and grinding operations. Storm sewers, earth excavation and embankment work will follow. Also, Brewster has removed the sidewalk and curbing under I-55/70, at Wilson Heights Rd.
- State and Federal Grant Funding
 - Still waiting to see if IDNR's OSLAD, PARC, and Bikeway grants will be reintroduced.
