- New Vehicle
 - MCT is considering donating another van in the coming months. If not, we can revisit the issue when drafting the FY19 budget.
- Gateway Center Future Donations
 - The Gateway Center has tentatively approved a \$450K donation on July 1st of 2018, 2019, 2020 and 2021 for a total of \$1.8M. These amounts are reflected on the most recent 5 year plan.
- Gateway Geyser Schedule
 - The Gateway Center is comfortable revising the geyser schedule in order to cut back on costs. If the board is comfortable with it, I would like to proceed with revising the park signage prior to next spring, stating the geyser will erupt May 1st through September 30th, seven days a week at noon.
- Revised Donation Agreement

- If the board agrees with the donations and revised geyser schedule, I will formally make the request to the Gateway Center, after which the donation agreement can be revised and MEPRD can officially approve the new donation agreement via a resolution.
- Future July 4th Events
 - The Gateway Center has suggested that we reduce the July 4th event budget whereby we open the park to the public, provide a safe environment and eliminate any costly frills.
